# NDSBA Annual Convention Features Four National Keynote Speakers and a Former NSBA President

Although this will result in fewer clinic sessions, issues presented during general sessions will be important to board members, business managers, and superintendents.

Also joining us this year is NSBA's past president **C.H.** "**Sonny**" **Savoie.** Sonny travels from his home in Louisiana to discuss the National Board Certification program for teachers and the role of school boards. These speakers will provide insight for attendees by sharing their unique knowledge, experience, and background.

# Governor's Education Summit

Governor Jack Dalrymple hosted a Governor's Education Summit in Dickinson on August 1, bringing together over 100 key educational leaders and officials from 20 different school districts and Higher Ed to discuss current status of our schools and share best practices. Governor Dalrymple used the opportunity to share a \$225 million proposal to enhance state support for school districts facing rapid student enrollment.

Dalrymple's proposal includes:

 Setting aside \$200 million in the state's strategic investment and improvement fund to provide lowinterest loans to qualified school districts throughout the state—not

iust in the oil counties- for the construction of new schools or for improvements or expansions to existing school buildings. Schools could receive up to \$20 million for a project and at interest rates as low as one percent. Loan applications

would be received and approved by the superintendent of public instruction based on need and the relative wealth of the school district. Loans would not be considered a debt for school districts in oilproducing counties, but rather a prepayment of future oil tax allocations.

Setting aside \$25 million in oil and gas impact grant funds during the 2013-15 biennium solely for rapidly growing schools impacted by oil development. Dalrymple said this money could be used for teacher housing, transportation issues, meeting needs of new and existing students, or anything that they can show is an impact due to oil development. These grants are funded with oil tax revenue. Dalrymple has said he again wants the state to set aside a total of \$135 million for impact grants for the next biennium to

help all local government entities in oil country.

 Forming an advisory group of western school superintendents, teachers, counselors, and school board members to keep state officials informed of school enrollments and immediate challenges.
 Dalrymple recently announced the appointment of Dr. Rick Buresh, former superintendent of Fargo Public Schools, as an adviser on rapidly growing schools. Dr. Buresh will assist superintendents and other school officials with planning and growth strategies.

Guest speaker at the Summit was

Superintendent **David Vroonland** of Frenship Independent School District in Texas. Vroonland chairs the Texas Fast **Growth Schools** Coalition, an organization of 102 fast growth schools in the state. Vroonland stressed the importance of school districts using demographers

who specialize in school demographic predictions. Every rapid enrollment school in Texas has a contract with a school demographer. Vroonland also repeatedly stressed the importance of involving and communicating with the whole community while planning and making decisions, saying "It's their kids, it's their money, and it's their schools." Dr. Vroonland identified a fear that most communities experience as they see rapid growth occurring. He said he senses that fear is the same in North Dakota: How can we protect and preserve our safe sense of community, friendliness and security in our towns? Vroonland said the answer is the schools. "School districts are the epicenters of culture and community of every town. Foster friendly relationships and quality educational experiences in your schools and your town will maintain its quality North Dakota way of life."

Oil industry experts provided insights

on the rapid growth in their industry, what they see for future growth in North Dakota, and how educational leaders can partner with companies to meet their needs. Mark Johnsrud of Power Fuels Oil Service Company sees the need for housing for his truck drivers based in Watford City so his company is building four 42-unit apartment complexes and 54 patio homes. Steve McNally, a Hess Corporation general manager, said companies will start looking for efficiencies but doesn't see any massive layoffs; instead, his company expects more workers will become permanent residents rather than flying in to work every two weeks at a big expense to the company. Russel Ranking, a regional manager for Statoil, said the Bakken-Three Forks is not another boom and bust. Instead, he sees another 14 years or so of drilling and another 35,000 new wells. "And that's just in the Bakken-Three Forks," he said.

Roundtable discussions included the following critical education-related topics: finance and housing; planning for a bond vote; maximizing school facilities; forecasting property tax collections; managing new construction projects; transient student needs, records; teacher recruitment strategies; enrollment projections; bussing and transportation; and fast growth issues with ND perspective. ## New TFFR Funding Contributions Take Affect

Teacher Fund For Retirement is the pension benefit provided to the state's public school teachers and administrators. Due to a funding shortfall created by the downturn in financial markets in 2008-2009, HB1134 was approved in the 2011 legislative session to create a long-term solution. The first of these changes took effect July 1, 2012.

Employer and employee contributions will increase a total of 8% shared equally between employers (4%) and employees (4%). The rate increases will be phased in as follows:

	Prior to 7/1/12	Effective 7/1/12	Effective 7/1/14
Employer	8.75%	10.75%	12.75%
Employee	<u>7.75%</u>	<u>9.75%</u>	<u>11.75%</u>
Total	16.50%	20.50%	24.50%

The increased employer and employee contribution rates will be effective until TFFR reaches a 90% funded level on an actuarial basis at which time the contribution rates will be reduced to 7.75% each.

It is possible contribution rates may have been part of your school district's negotiated agreement. Check with your business manager to learn what impact this is having on your school district's budget. A 9.75% employee contribution is required on all salary earned by re-employed retirees performing TFFR-covered employment as well.
