Travel Reimbursement Rates Changing

Effective August 1, the following rates apply for travel within the state:

- First quarter is from 6 a.m. to 12 noon and the sum must be seven dollars. First quarter reimbursement may not be made if travel began after 7 a.m.
- Second quarter is from 12 noon to 6 p.m. and the sum must be ten dollars and fifty cents.
- Third quarter is from 6 p.m. to 12 midnight and the sum must be seventeen dollars and fifty cents.
- No changes were made to fourth guarter lodging reimbursement.

The North Dakota Industrial Commission recently approved the biennial allocation plan for the state's Housing Incentive Fund (HIF), allowing

the North Dakota Housing Finance Agency (NDHFA) to accept applications from multifamily housing developers and contributions from taxpayers. The 2013 Legislature reauthorized the fund at \$35.4 million and established program priorities of providing

of providing affordable housing for essential service workers in energy-impacted counties and preserving and providing for the needs of low- to moderate-income households statewide.

Attorney General Issues Open Records Opinion

On May 24, 2013, the North Dakota Attorney General issued an opinion to North Dakota State University (NDSU) regarding a record request for student disciplinary records. The Attorney General found NDSU violated the open records law by providing an insufficient written denial to the request.

On October 22, NDSU received a request for "the details of any disciplinary action taken against the NDSU football players who were charged and convicted of petition signature fraud earlier this year." Requested information included "details of any action taken academically, through student government, and/or the athletics department." NDSU refused to provide the requested disciplinary records stating that the records were confidential under the Family Education Rights and Privacy Act (FERPA) found at 20 U.S.C. §1232g, and 34 C.F.R. Part 99.

The Attorney General stated that the "Department of Education has consistently issued letter opinions which recognize that occasionally information could be traced to individual students. even if the records are redacted and even when information is released in the aggregate. In those instances, FERPA prohibits disclosure of the information without consent when, taking into account all available information, data. and other information known to have been disclosed by other means such as through the media, the educational institution determines the records could still identify students."

The opinion stated that if the school determines that the requested records cannot be redacted without retaining some personally identifiable information, the records cannot be released. If the request asks for a specific student's

Convention Committee Members Sought

Several months prior to each NDSBA Annual Convention, three committees are selected to assist with the convention process. The **Nominating Committee** recommends a slate of candidates to be presented to the Delegate Assembly. A **Credentials Committee** oversees the registration process, reports appropriate numbers

to the Delegate Assembly, ensures delegates are properly seated, and counts floor votes when required. The **Ballot Counting Committee** counts ballots and verifies election results.

Policy Services Renewal Reminder

NDSBA will mail Policy Services renewal notices to school districts in June. NDSBA Seeks Resolution Recommendations

NDSBA members create the association's legislative agenda through adoption of resolutions.

NDSBA resolutions fall into one of two categories: Beliefs and Policies or Standing Resolutions. Beliefs and Policies are permanent philosophical, legislative, and operational statements; Standing Resolutions are uniquely legislative and are dropped after four years unless they are brought to the Delegate Assembly for reconsideration.

Current Beliefs and Policies and Standing Resolutions—along with a recommended submission format—are available at www.ndsba.org under both the "About NDSBA" and "Legislation" links.

It is time to think about resolutions your board may want to submit. The 2013 Legislative Session showed a continued shift in political philosophy moving toward more legislative control over policy, procedure, and accountability of local government, including school districts. Your district might want to discuss possible resolutions regarding property tax limitations, defined contribution retirement plans, local control of curriculum content, administrator and teacher evaluations, or collective bargaining and negotiations.

Resolutions must be received in the NDSBA office by **4:00 p.m. on Monday, August 12**, to be considered by the NDSBA Governmental Affairs Committee for recommendation to the Delegate Assembly at the Annual Convention.

Reminder

North Dakota Century Code section 15.1-09-31 requires a school board to publish an itemized list of obligations approved for payment, if so determined by the voters. The North Dakota Attorney General has issued an opinion stating that this includes a one-time listing of annual salaries of school district employees at the time the contract is signed or at the time the individual begins his or her duties, in lieu of itemization of monthly payments to each employee. disciplinary records, it is reasonable to conclude that the student's identity would be obvious and would be disclosed to the requestor.

The Attorney General concluded that the response that is provided when denying a records request must contain a sufficient written denial. Generally stating that students' discipline records are confidential is not accurate. It is a violation of the open records law to deny a record using an inaccurate legal reason.
