2. At the second Business Session on Friday afternoon, the chair will ask if there are resolutions that were distributed on Thursday. At that time, a delegate from your board must come to the microphone and move the resolution. A delegate from a different board must make the second.
3. Once a motion and second have been made, your resolution will be discussed and voted on by the Delegate Assembly.

Welcome from NDSBA's Executive Director

As I continue in my first year as your new Executive Director, I am filled with gratitude for the trust the NDSBA Board of Directors and our members have placed in me to lead our esteemed association. Having been part of the NDSBA team for over seven years, this transition has been both smooth and invigorating. I've approached my new role with fresh eyes, identifying opportunities to enhance our impact and effectiveness. I'm excited to share with you some of the significant strides we've made and the challenges we've tackled together this past year.

A key addition to our team has been KrisAnn Norby-Jahner, our new General Counsel. With 15 years of legal experience specializing in employment and education law. Her expertise has already proven invaluable in providing strategic guidance and managing our legal and policy services programs.

This past August, after more than a year of planning, we launched a new membership management system and policy services software. While the transition required significant effort from our staff and continued patience and understanding from our members (which is greatly appreciated), we're confident that these improvements will meaningfully enhance your experience with our association. We also launched a new Business Manager Mentoring Program and have our first cohort of Mentors and Mentees that are signed up to the program.

In June, the NDSBA Board of Directors voted to maintain its membership in the Consortium of State School Board Associations (COSSBA) and drop its membership in the National School Boards Association (NSBA) for the upcoming fiscal year. The Board determined that membership in COSSBA was a better fit for NDSBA and our members. COSSBA will hold its annual conference for local school board members on March 21-23, 2025, in Atlanta, GA. Please contact our office or go to COSSBA's website (www.cossba.org) for more information.

We've been actively involved with the Keep It Local Coalition, opposing Measure 4, which seeks to eliminate the ability of local governments, including school districts, to levy property taxes. As of September 30th, the Coalition has grown to an impressive 110 members across multiple industries in ND. With this broad support, the Coalition has engaged in an extensive public education campaign about the potential consequences of Measure 4 should it pass this November.

In addition, over the past year, NDSBA staff has closely monitored the work of several interim legislative committees, including the Education Committee, the School Funding Task Force, and the Property Tax Relief Advisory Committee. While specific legislation plans are yet to be announced, we anticipate a record number of bills in the upcoming session that may impact K-12 public education. The potential approval of Measure 4 in November could significantly impact local government funding, creating an estimated \$3.15 billion shortfall, which would likely occupy most of the Legislature's focus during the upcoming session. Rest assured, we are preparing to navigate these challenges and advocate for the best interests of our members and K-12 public education in North Dakota regardless of the election results.

As we move forward, NDSBA remains committed to our mission of empowering all North Dakota school boards to be effective leaders of their districts and strong advocates for public education. Thank you for your trust and dedication to serving your communi. I look forward to another year of collaboration and progress. As always, please feel free to contact our office for assistance and guidance.

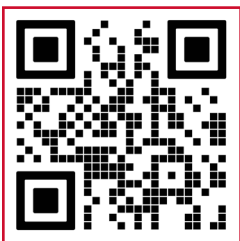

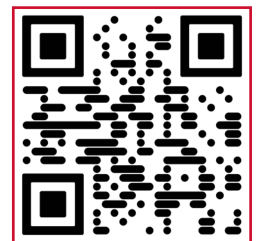

2023 Minutes

NDSBA Business Session and Delegate Assembly Minutes October 26-27, 2023

The 2023 North Dakota School Boards Association Business Session was called to order by President Patti Stedman at 4:15 p.m. on Thursday, October 26, 2023.

The Standing Rules were unanimously adopted as presented via voice vote.

The report of the Nominating Committee was given by Chair Nikkie Gullickson, Fargo School District:
Nominee for President: Patti Stedman, West Fargo; Nominee for Vice President: Lucas Greff, Mott/Regent; Nominee for Northeast Director: Marlana Knudson, May-Port CG; and Nominee for Southwest Director: Michelle Orton, Dickinson.

There were no nominations from the floor. The candidates each gave a short campaign speech.
Robin Nelson, Fargo, made a motion to cast a unanimous ballot for all offices. The motion was seconded by, Blake Seibel, Beulah, and passed unanimously. This eliminated the need for a ballot election on Friday, October 27 and confirmed the 2023 election results.

President Stedman called for the Ballot Counting Committee to be on standby in case any resolutions moved to a paper ballot.

Past President Karl Lembke, chair of the Government Affairs Committee, presented four resolutions recommended for re-adoption as written and three resolutions recommended for re-adoption as amended.

President Stedman thanked the Government Affairs Committee members for their work in reviewing all proposed resolutions. No additional resolutions were offered from the floor for consideration.

Door prizes were awarded to attendees.

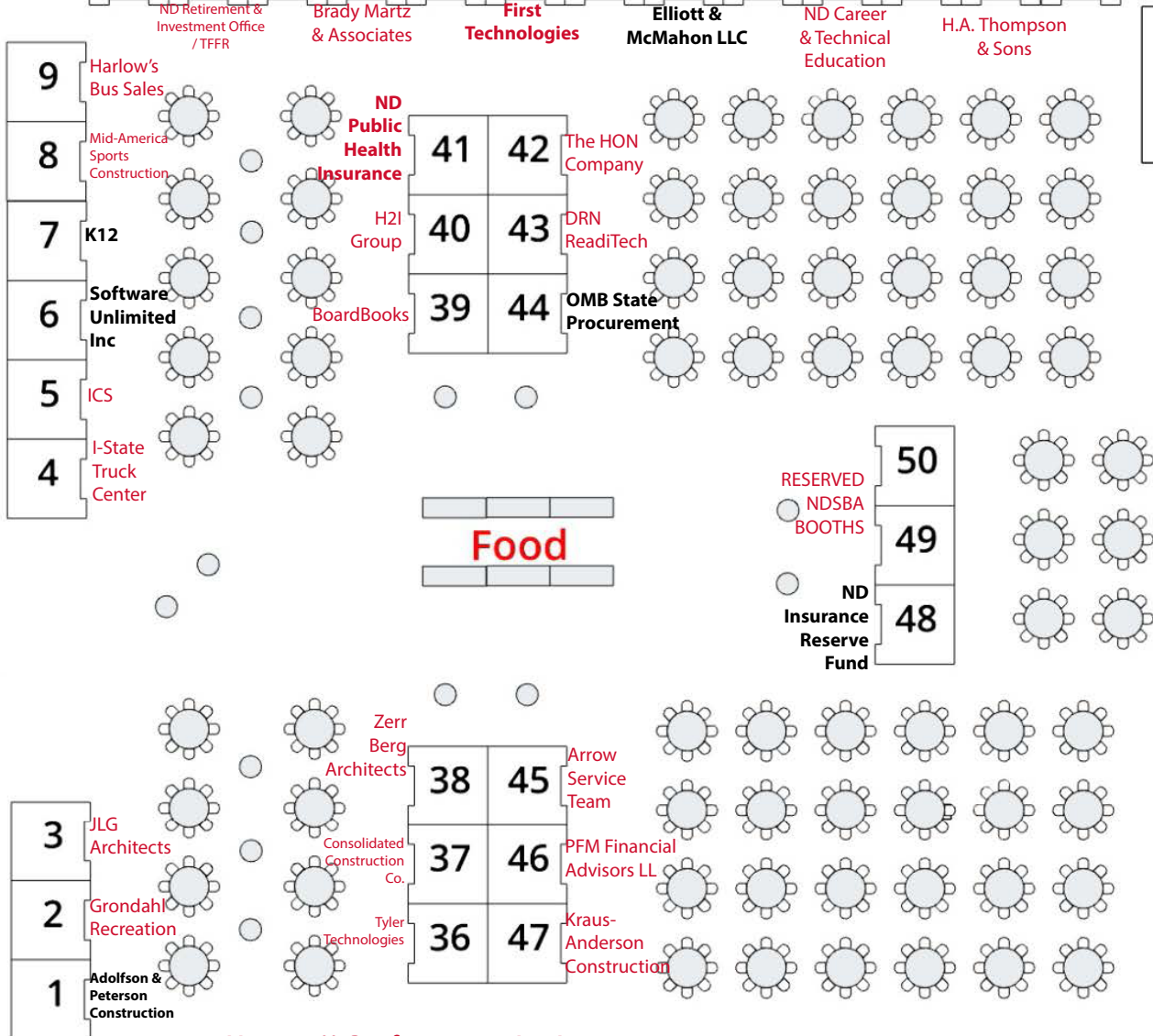

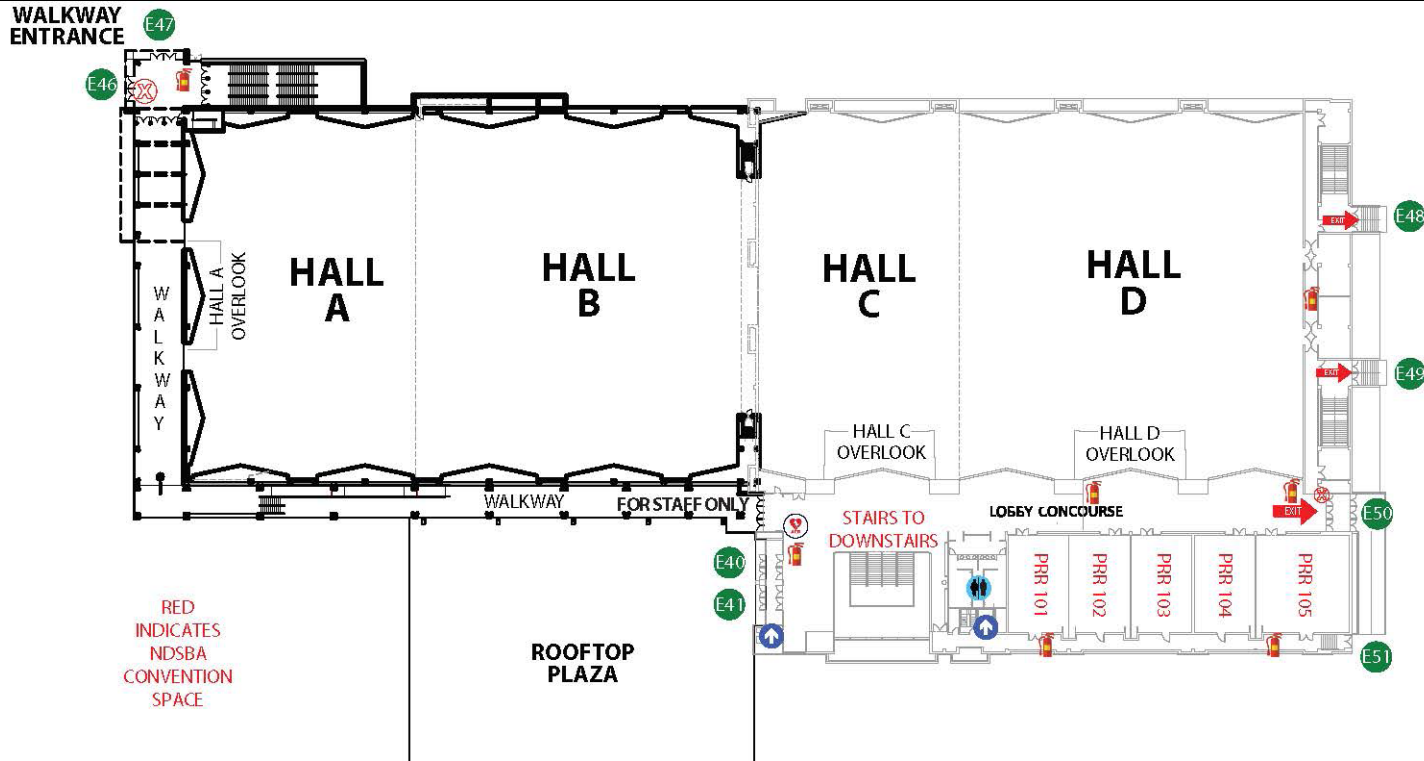
