Convention delegates and alternates must have their names submitted to the NDSBA office by OCTOBER 13 in order to vote in the Delegate Assembly. *There will be no exceptions.* If you are not sure who will be attending, submit all possible names as either delegate or alternate. They will be allowed to change status at the convention only if their names were submitted by the deadline.

The formula for determining delegates is:

<u>Number of Teachers Employed</u>	<u>Number of Delegates</u>
0-10	1
11-30	2
31 and over	3

In addition, districts with a pupil population of 1,000 or more shall be authorized increased representation as follows:

<u>Pupils</u>	<u>Number of Delegates</u>
1,000 - 4,999	1
5,000 - and over	2

The maximum number of delegates a district may have is five.

Only elected school board members may serve as delegates and alternates -- administrators, county superintendents, and business managers are not eligible to vote. Counties and multidistricts are nonvoting members.

NOTE: Annual dues must be paid in order for delegate to vote at the annual convention.
