## Program in Grand Forks Public School District Earns 2023 NSBA Magna Award

NSBA's Magna Awards program is known for recognizing exemplary school district programs. The focus of the 2023 awards program was innovation in education and it honored districts that have implemented programs that solved district challenges with creativity and out-of-the-box strategies. Among the 2023 Magna Award winners is the Mentor Center in the Grand Forks Public Schools District.

The Mentor Center was one of the three award winners in the 5,000 to 20,000 enrollment category in the Silver Award winning programs. Only 18 districts in the nation receive a Magna Award each year. Along with the other winning districts, they were featured in the April 2023 issue of *American School Board Journal* and were recognized during the NSBA Annual Conference at the Magna Awards Master Class and reception.

The Mentor Center is a resource center for middle and high school students to receive academic support, social-emotional support, and enrichment. It originally started



as a pandemic response to help struggling students and quickly became a key element in students' lives, what sociologists term a "third place," a place in between school/work and home, somewhere that enriches lives and builds community. Not even a year after its open date of January 2021, the Mentor Center received the 2021 Governor's #InnovativeND Award for Collaborative Culture. The center has transformed into a broad program that offers and maintains a positive, welcoming environment for all, establishes expectations for students, is more integrated in the



work of the schools, and assists the district in its strategic goals for academic engagement and social emotional learning.

# Legal Spotlight

## How to Change the Size of a School Board

Several districts have recently contacted us regarding the process to change the size of their school board. North Dakota law requires that school boards be made up of either five, seven, or nine members. The size of a board may be increased or decreased as districts expand, shrink, or reorganize.

Under North Dakota Century Code Section 15.1-09-01, the size of a school board may be increased to seven or nine members or decreased to seven or five members only if a petition is submitted to the board that is signed by the requisite number of qualified electors of the school district. The requisite number of qualified electors is equal to at least one-third of those who voted at the most recent annual school district election. The board may not initiate such a change or circulate a petition for this purpose. Rather, the

board must only act upon receipt of a petition containing the requisite number of signatures. Additionally, the school business manager is not required to verify the sufficiency of the petition prior to signatures being collected. The verification occurs following receipt of a petition containing at least the requisite number of signatures. Once the board receives a proper petition, the question is placed on the ballot at a special election called by the school board for this purpose. The change must be approved by a majority of the qualified electors of the school district voting on the question at the special election.

If a majority of the qualified voters in a school district elect to increase the size of the school board, the additional members must be elected to the board at the next annual school district election in the same manner as other board members. If the total number of board members after approval of the increase is seven, the terms of three members extend until the first annual election, the terms of two members extend until the second annual election, and the terms of the remaining two members extend until the third annual election. If the total number of board members after approval of the increase is nine, the terms of three members extend until the first annual election, the terms of three members extend until the second annual election, and the terms of the remaining three members extend until the third annual election.

The length of any term in existence before the change in board membership and held by a board member who is duly qualified may not be modified as a result of the change. If a majority of the qualified voters in a school district elect to decrease the size of the school board, no existing board member's term is cut short. The excess number of members serve out their existing

terms and then their seat circulates off of the board when next up for election.

Please note that it is not uncommon to consider increasing or decreasing a school board while also considering the process of reorganization. An election on a reorganization proposal takes the place of the petition and election requirements of increasing or decreasing a school board discussed above. Approval of a reorganization proposal has the same effect as if the approval were by the election provided for an increase or decrease of a board. Once reorganization is complete, any increase or decrease of the school board may occur through a change in the reorganization plan, which is addressed in NDCC 15.1-12-21.

## NDDPI Seeking Applications for Summer Food Service Program



The Department of Public Instruction is seeking applications from organizations interested in operating North Dakota's Summer Food Service Program. The program offers meals to children when school is not in session.

Potential sponsors include residential summer camps, private nonprofit

organizations, public schools, nonprofit private schools, and local, municipal, county, tribal or state government units. Eligibility rules require that at least 50 percent of the children who are served meals – or who are living in the area – must be eligible for free or reduced-price meals, based on local school or census data.
